The deadline for submitting Community Project Funding requests to our office is April 9, 2021. This limited timeline is due to external deadlines that our office does not control. Please do your best to ensure your submission is made on or before April 9, 2021.

The following account are eligible for funding and will be subject to account-specific eligibility criteria and matching amounts:

- 1. Pre-Disaster Mitigation Grants
- 2. Nonprofit Security Grants
- 3. Emergency Operations Center Grants

The subcommittee will not accept project requests in any other account.

More information on this specific account is included below:

1. Pre-Disaster Mitigation Grants- Pre-Disaster Mitigation Grants: These grants fund planning or projects to lessen the impact of future disasters, such as stormwater projects or buying out properties in flood-prone areas. Only projects that meet the requirements (including applicable cost-share, environmental, and historic preservation requirements) in the most recent Notice of Funding Opportunity

(<u>https://www.fema.gov/sites/default/files/2020-08/fema\_fy20-bric-notice-of-funding-opportunity\_federal-register\_August-2020.pdf</u>) for the Building Resilient Infrastructure and Communities (BRIC) grant program will be considered.

\*\*CPF requests in the Pre-Disaster Mitigation Grant account must clearly address the following questions in their submissions:

(a) Is the requesting jurisdiction a state, Indian tribal government, local government, or territory as defined by section 102 of the Robert T. Stafford Disaster Relief and Emergency Assistance Act (42 U.S.C. 5122)?(b) Is the proposed project eligible under the most recent Notice of Funding Opportunity for the Building

Resilient Infrastructure and Communities grant program?

(c) Can the requesting jurisdiction provide the required non-federal cost share, consistent with 2 CFR Sections 200.29, 200.306, and 200.434?

(d) Can the requesting jurisdiction provide a Cost-Benefit Analysis or other documentation that validates cost-effectiveness, which is defined by FEMA as having a Benefit-Cost Ratio (BCA) of 1.0 or greater? A non-FEMA BCA methodology may only be used if pre-approved by FEMA in writing.

2. Nonprofit Security Grants- These grants fund security expenses—such as cameras, contract services, or training—for nonprofits at a heightened risk of terrorism, broadly defined. Only projects that meet the requirements detailed in the most recent Notice of Funding Opportunity

(https://www.fema.gov/sites/default/files/documents/fema\_fy2021-nsgp-nofo\_3-2-2021.pdf) and the Preparedness Grants Manual (https://www.fema.gov/grants/preparedness/manual) for the Nonprofit Security Grant Program will be considered. There is no cost share requirement for Nonprofit Security Grants. \*\* PF requests in the Nonprofit Security Grant account must clearly address the following questions in their submissions:

(a) Is the entity for which funding is proposed a non-profit organization as described under section 501(c)

Please provide a description of how the requested funding would be used and how it would help you serve IL-10: \*

This flood mitigation project will alleviate wide-spread flooding and drainage problems in North Chicago. The requested funding will aid in the installation of a 3,225-foot upsized storm sewer from Strawberry Condos & Bittersweet Ave to the Skokie River, the removal and replacement of two box culverts within the Skokie River, replacing an outlet control structure, and constructing 40 acre-feet of compensatory flood storage. The compensatory storage allows for the upstream improvements proposed upstream of the Skokie River and within the Skokie River without adversely impacting downstream communities. This project also, provides much needed flow capacity to the existing undersized storm sewer system that is currently in place.

Please provide a justification for why this project is a good use of federal taxpayer funds: \*

This project benefits the following local, county and state jurisdictions; the City of North Chicago (including private landowners), Illinois Department of Transportation (Route 41), Naval Station Great Lakes properties and Hunt Company properties (Naval housing area). These funds will not only help implement this flood mitigation project, but will also support a large local, county, and state jurisdictional partnership already implementing steps to ending this chronic flooding. Implementation of this project will address tributary drainage problems greater than 100 acres, flood protection of a minimum of a 10-year storm event or more and addresses known/reported flood problem areas in the watershed.

Include a detailed budget describing how funds will be used: \*

Project Implementation costs include: \$2,331,200 in upsized storm sewer systems, \$158,895 in culvert removal/replacements, \$1,005,315 towards pond improvements and \$6,900,000 towards compensatory flood storage. Design & Engineering costs are not included in this budget and will be provided as in-kind cost match. A detailed budget can be provided. Lake County understands the project cost share is 25% and will make sure this requirement is fully met.

F. Yes; The 40 ac-feet compensatory flood storage will compensate for the flood mitigation efforts described in the project scope of work without creating any adverse impacts to upstream or downstream communities. This project addresses a problem that has been repetitive or that poses a risk to public health and safety and contributes, to the extent practicable, to a long-term solution to the problem it is intended to address. This project also, accounts for long-term changes to the areas and entities it protects and has manageable future maintenance and modification requirements.

G. Yes; The proposed upsized storm sewer systems and compensatory storage system took into account the increased rainfall analysis information. This project took into account high winds and continued sea level rise and ensures responsible floodplain and wetland management based on the history of flood mitigation efforts and the frequency and intensity of precipitation events.

H. Yes; This project area is located in an Environmental Justice Area: HUD Low-Moderate Income area (59.82) and Entitlement Community (City of North Chicago). The chronic flooding in this area has halted roadway use along U.S. Route 41 and Illinois State Route 137 and adversely impacting residents, businesses and industrial areas (some forced to close).
