This downtown cornerstone property has been vacant for decades. The rehabilitation of this historic building will be a jumpstart to the needed community revitalization. This building and the revitalization of downtown Waukegan have been listed in community development plans dating back to at least 1987 and the time of the industrial decline in the District. As defined by HUD, the immediate area has 68.9% low/moderate income residents. The project has a large potential for HUD defined "Area Wide Benefit". The economic impact is expected to spread to the area's 13 retail stores, 8 restaurants/bars, 3 performance venues, and more. This is project with revitalization components, safety benefits, education, and cultural enrichment.
